- Events hiring such as weddings and private functions.

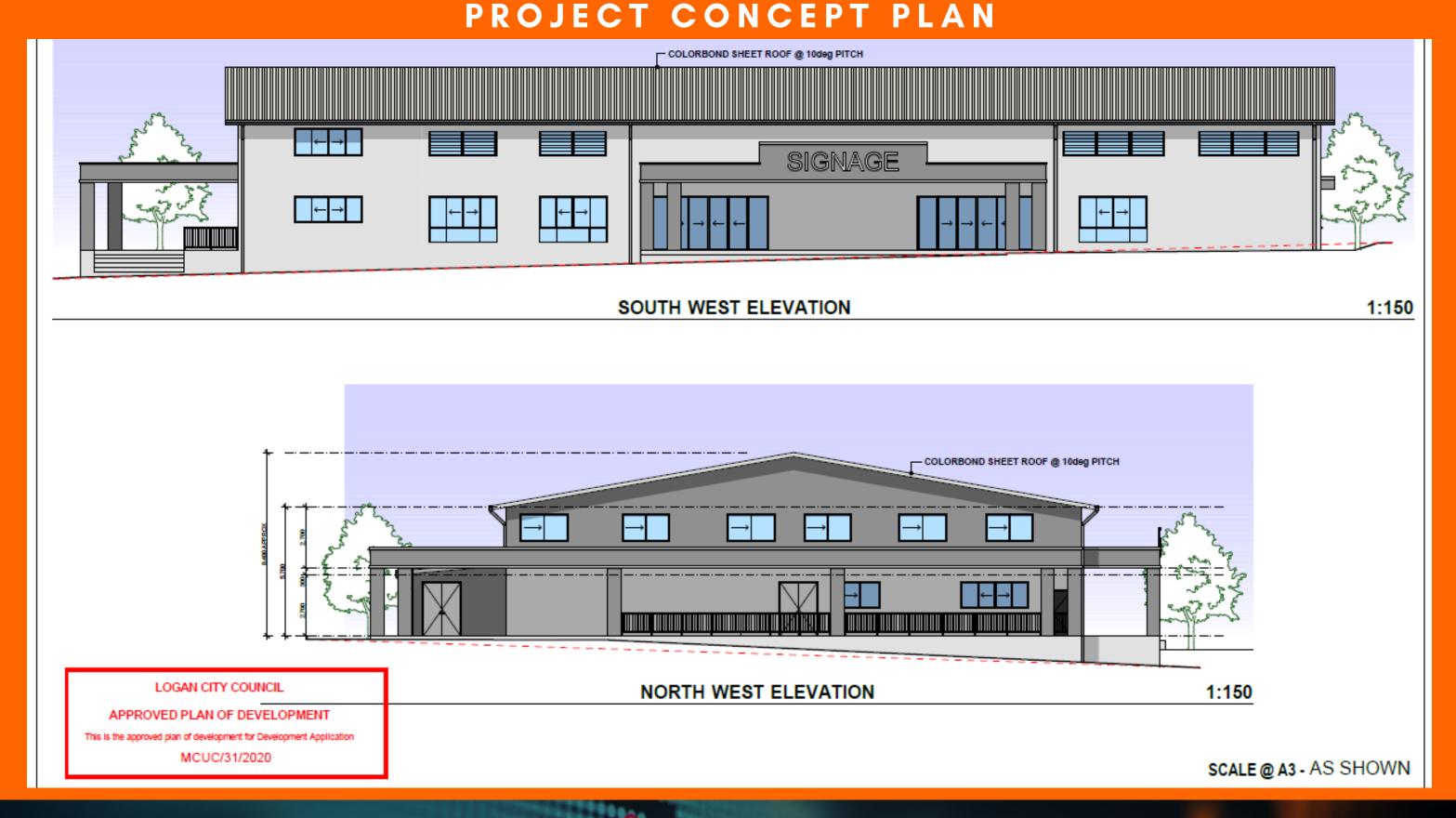

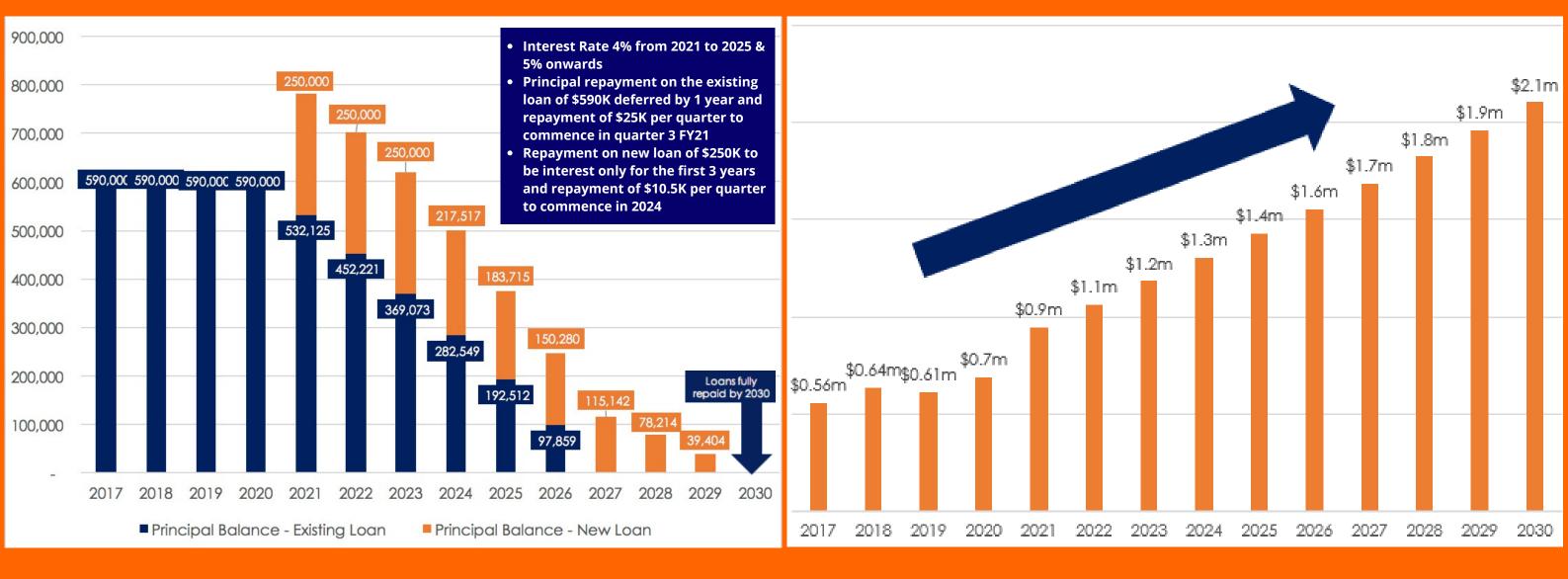
